#### Investing in our schools

The NSW Government is investing \$6 billion over the next four years to deliver more than 170 new and upgraded schools to support communities across NSW. In addition, a record \$1.3 billion is being spent on school maintenance over four years. This is the largest investment in public education infrastructure in the history of NSW.

#### **Canterbury South Public School**

A project is underway to redevelop Canterbury South Public School. The project will deliver:

- new classrooms increasing the school's enrolment capacity to accommodate 690 students
- an upgrade of core facilities including hall, library, canteen and administration buildings.

#### **Progress Summary**

Stage 1 works including the tree removal were completed recently in accordance with planning legislation. The redevelopment is due for completion in mid-2021.

#### Next steps

As part of the stage 1 works, contractors will install demountables, and will commence demolishing some buildings and construct new core facilities.

The Development Application (DA) for the main works has been submitted to the City of Canterbury Bankstown Council for approval. The community can view the DA at Council's Campsie Customer Service Centre or Campsie Library and Knowledge Centre and are invited to provide feedback until 17 April 2019.

It is anticipated that main works will start in mid 2019, subject to planning approvals.

During this time, we will be working with the school community and neighbours to ensure that disruptions to the community are minimised.

## Frequently asked questions

## What works will take place in April?

The contractor will install demountables, and a COLA and create access ways and paths.

## What are the hours of work?

Construction work hours will comply with Council requirements.

We are here to make sure that work is completed safely and efficiently and we will minimise impact on the community at every opportunity.

### Is there an impact to current school operations?

No. School operations during Term 2 will continue as usual.

# What steps will be taken to control noise and dust impact?

Hoarding and shade cloth will be erected to reduce noise and dust impacts on the school and our neighbours. Dust from demolition and construction works will be hosed down with water as required.

## How will traffic be managed?

The site will be separated from the school grounds by security fences and hoardings and contractors will enter the site via dedicated entryways. Traffic management measures will be put in place to ensure access around school grounds is managed.

Construction vehicle movements and deliveries will be scheduled to minimise impacts to peak times.

## How will you keep us informed?

School infrastructure NSW is committed to keeping the school community and near neighbours informed about the project. We do this by holding information booths at the school, issuing project updates via letterbox drops, website updates and through the school newsletter.
