

Darcy Road Public School

Works notification | 8 March 2024

The upgrade of Darcy Road Public School will provide new permanent classrooms and core facilities to support the growing population in Western Sydney.

The NSW Department of Planning, Housing and Infrastructure (DPHI) has approved the State Significant Development (SSD-49073460) for the upgrade and provided the conditions of consent. The conditions of consent are available on the DPHI Planning Portal:

Main works starting

The main upgrade works will start in March 2024. Initial works will involve demolition of the existing school buildings that are fenced off within the construction area.

These buildings have been cleared of asbestos containing material and lead during work undertaken in the school summer holidays by licensed and accredited contractors. The contractor has received a clearance certificate from an independent hygienist confirming that the buildings have been fully remediated.

Managing construction impacts

A Construction Environmental Management Plan (CEMP) and sub-plans have been prepared for the upgrade that detail how construction impacts will be managed for the community. Measures include:

- acoustic shielding, where practical, to minimise noise from the site
- using shade cloth to reduce dust impacts on the school and its neighbours
- hosing down dust from construction works, as required
- covering the loads of trucks entering and leaving the site and washing them down to prevent tracking dust and mud tracking from the site
- scheduling deliveries outside of school drop off and pick up times, where possible
- encouraging construction workers to use public transport to travel to and from the site.

Remediation works

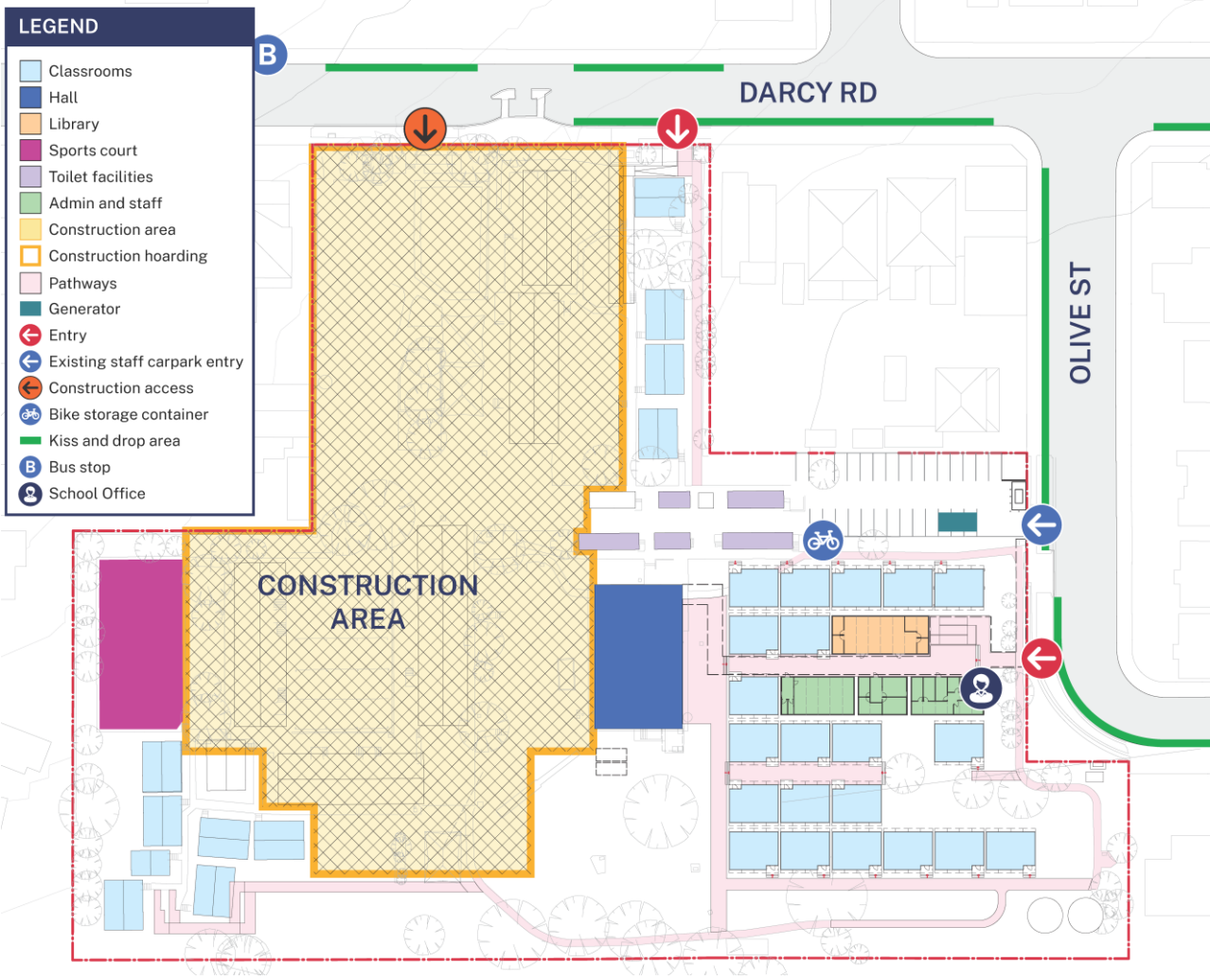
Should unexpected finds of asbestos containing materials occur during the main upgrade works, they will be managed in accordance with an unexpected finds protocol, in accordance with SafeWork NSW regulations and the NSW Department of Education's Asbestos Management Plan.

Working hours

The approved working hours for the project are 7 am to 6 pm, Mondays to Fridays and 8 am to 1 pm, Saturdays. No work may be carried out on Sundays or public holidays. Provided noise levels do not exceed the existing background noise level plus 5 decibels, works may also be undertaken from 6 pm to 7 pm, Mondays to Fridays and 1 pm to 4 pm, Saturdays.
