Epping West Public School upgradeWorks notification

A project is underway to upgrade Epping West Public School. The project will deliver new classrooms and an administration facility, refurbishment and renovation work to existing buildings and removal of temporary classroom facilities.

Early works, including site establishment and demolition of Building G, began in September 2021 and are progressing well.

Epping West Public School upgrade - main works starting

Main works construction is starting for the Epping West Public School upgrade from Wednesday 20 October 2021.

The first milestone for main works will be the construction of Building S. Building S is located to the southwest of the school site near Ward Street.

The map overleaf shows the location of Building S and the school access gates.

- Gate 1 Carlingford Road is the main access for students, the pedestrian overbridge from Ryde Street remains in use.
- Gate 2 Currently non-operational.
- Gate 3 The Kiss and Drop from Ward Street remains functional.
- Gate 4 The left hand gate is for access for OOSH.

There will be no construction traffic during drop-off and pick-up times for Epping West Public School.

Working hours

Work will take place between the following times:

• Monday to Friday, 7am to 6pm and Saturdays, 8am to 1pm.

Frequently asked questions

How will dust and noise be managed during construction?

Any activity that could exceed approved construction noise management levels will be managed in accordance with the Protection of the Environment Operations Act 1997. Noise will be kept to a minimum as best as possible during the construction, and dust as a result of demolition and excavation, will be hosed as required. Trucks making deliveries to the site will have their loads covered. The site will undergo air monitoring during inground works and noise and dust will be appropriately managed throughout construction in accordance with the State Significant Development application consent conditions.
