Out of Hours Work (OOHW) Request, Condition C6

Dear Ms Sellen

I refer to your OOHW request seeking the Planning Secretary's approval under condition C6 of SSD-10340.

I note the OOHW request:

- has been reviewed by the Applicant, and no issues have been raised to the Department;
- is for 4 nights to undertake works associated with the previous dismantling of scaffolding and temporary gantry associated with the northern section of the TfNSW Bradfield Shed works only;
- relates to the installation of permanent fencing adjacent to the Cahill Expressway, electrical changeover to the Cahill Expressway and a site survey for the dilapidation report associated with TfNSW Bradfield Shed works;
- includes TfNSW Road Occupancy Licence which only permits for night-time works for the 4 nights;
- confirms that previous scaffolding dismantling and steel installation OOHW noise levels, measured at the nearest sensitive receptor, did not exceed the existing background noise level plus 5dB; and
- has been submitted to the Secretary before conducting the OOHW.

As nominee of the Planning Secretary, I approve the OOHW request, under condition C6 of SSD-10340 for 4 nights (see Attachment 1) subject to the same requirements listed (1. to 5.) in the Department previously approved OOHW under SSD-10340-PA-79.

Please note that this approval may be reviewed should there be noise, parking or traffic complaints, or if the works are not implemented in accordance with the approved OOHW application.

Also, please make the OOHW request with supporting documents available for public access on the project website at the earliest convenience.
