Change to information sessions

Project overview

The Fort Street Public School upgrade will cater to growing enrolments and provide exciting new spaces for learning and teaching.

Under the SSDA, we are proposing to increase the school's capacity up to 550 students through a range of new and refurbished buildings, which will be sensitive to the area's character and heritage.












Indicative project timeline



What is a State Significant Development Application?


State Significant Development Applications (SSDAs) are used for projects that have special significance to the people and State of NSW. The Department of Planning, Industry and Environment (DPIE) is responsible for the planning approval process for SSDAs, rather than a local council.


Existing site plan

The site plan below shows the proposed layout of the upgraded Fort Street Public School buildings and grounds. This plan shows the location of a range of proposed new and refurbished buildings, together with longer term plans for the school site.



Proposed changes to the site

The Fort Street Public School upgrade includes a range of proposed new buildings and refurbishments to existing buildings, as outlined below and indicated on the future site plan (page 3):

- A new building on the western part of the site for a staff room (Building F)
- Two new, interconnected school buildings (Buildings H & J)
- New school hall and canteen building (Building G)
- Refurbishment and extension of the existing Fort Street Public School building, including the construction of a rooftop play area (Building A)


- Refurbishment of the Bureau of Meteorology Building, including internal alterations and rooftop terrace (Building M)
- Minor alterations to the Messenger's Cottage (Building C).

Longer term plans

Our longer-term plans for the school include a proposed pedestrian bridge over the Cahill Expressway and a new school building on the north-west of the site (indicated by the blue shade on the future site map). However, neither of these proposals are part of this SSDA and may be delivered at a later date through separate development applications.





Transport and access

To support a larger student population, we are proposing to make the following changes to vehicle and pedestrian connections to the school:

Widening Upper Fort Street to remove pinch point


The section of Upper Fort Street near the entrance of the school currently only allows for one-way traffic. This can result in traffic congestion at busy times of the day. We are proposing to widen this section of the street to six metres, which will allow for two-way traffic and improve traffic flow.

Drop-off/pick-up zone

We are proposing to modify the drop-off/pick-up zone on Upper Fort Street to allow for:

- up to 30 queued vehicles
- additional queueing area for 18 vehicles along Watson Road
- 15-minute free parking for parents and carers to park and access after school care (or at times when the pick-up line is not in operation).

At other times, the existing 2P and 4P parking controls will apply.



Managing construction impacts

Hours of work

The hours of work for the project are expected to be consistent with standard Sydney CBD construction working hours:

- Monday to Friday: 7:00am 7:00pm
- Saturday: 7:00am 5:00pm
- Sundays and public holidays: no works.


Out of hours work will be considered on a case-by-case basis and will need to be approved by the Department of Planning, Industry and Environment.

Truck movements

We anticipate there will be up to 25 to 50 vehicles moving in and out of the site each day. We expect that truck movements will be focused on the western side of the site via Sussex Street and Kent Street.

Temporary diversion of the cycleway

As the Sydney Harbour Bridge southern cycleway currently passes over the school site, we will need to reroute the cycleway during construction from Kent Street to the Sydney Harbour Bridge. The proposed cycleway detour is an on-road route along Kent Street, Argyle Street and Watson Road.

What is the student capacity of the proposed new Fort Street Public School?

550

When will the school reach capacity?

Enrolments are anticipated to increase year by year. We expect that it will take several years for the school to reach its full capacity.

Construction

When will construction start?

We expect early works will begin in the second half of 2020. Pending SSDA approval, we expect construction will start in the first quarter of 2021. We will keep you updated on these timeframes as approval is given and the project progresses.

When will you build the proposed pedestrian bridge on the western side of the school?

The pedestrian bridge is part of a long-term masterplan for the school site, which may be built at a later date after the completion of the Fort Street Public School upgrade. This will require separate approvals.

Sydney Harbour Bridge Cycleway

Where will the cycleway be diverted during construction?

The proposed cycleway detour is an on-road route along Kent Street, Argyle Street and Watson Road.

The proposed Sydney Harbour Bridge Cycleway upgrade is being managed by Transport for NSW and is not part of the Fort Street Public School upgrade.
