EXECUTIVE SUMMARY

The NSW Department of Education – School Infrastructure NSW are responsible for delivering the Galungara School Development (the Project). The Project involves staged construction of the school to cater for up to 1,000 primary students. Stage 1 and 1A are now completed and this and operational as of Day 1, Term 1 2021. Consent for the Project, State Significant Development (SSD) 9368, was granted on 21 May 2020, subject to a number of Conditions of Consent (CoC) which have been modified on three occasions.

Construction of Stage 2 of the Galungara Public School began in March 2022. Stage 2 includes: 20 new learning spaces; two additional covered outdoor learning areas; two new multipurpose games courts and landscaping works.

TSA Management (TSA) has been appointed as the client representative on behalf of School Infrastructure NSW (SINSW). Richard Crookes Construction (RCC) is the principal contractor. The Principal Certifying Authority (PCA or the Certifier) is Group DLA (DLA).

Conditions of Consent (CoC) C30 – C38 of Schedule 2 of SSD 9368 set out the requirements for undertaking Independent Audits. The Department of Planning Industry and Environment (the Department) document titled *Independent Audit Guideline Post Approval Requirements*, 2020 (IAPAR) have been adopted for this audit

This Audit Report presents the findings from the first Independent Audit for the Stage 2 construction period, covering the period from March 2022 to June 2022 (the audit period). The objective of the Independent Audit is to satisfy SSD 9368 Schedule 2, Part C, CoC C31-33. It requires that Independent Audits of the development be carried out in accordance with Project's Independent Audit Program and the requirements set out in the IAPAR.

The scope of this audit covers Stage 2 of the Project. Previous Independent Audits have been conducted during Stage 1a and 1b work which is now in operation. During this current audit period Stage 2 construction work has commenced including site establishment work, preparation of the site access and egress from the eastern end of Farmland Drive, initial earthworks and commencement of structural building work.

The overall outcome of the Independent Audit indicated that compliance is being proactively tracked by TSA and RCC. Compliance records were well organised and available during the Independent Audit. Relevant environmental and compliance monitoring records are being collected and reported as required to provide verification of compliance to statutory requirements and the broader Project environmental requirements.

Detailed findings are presented in Section 3, along with recommended actions to address each of the findings. The findings are summarised as follows:

- As this is the first Independent Audit for Stage 2 work there are no open findings and recommendations from the previous Audits
- With respect to the finding from this first Independent Audit of Stage 2:
 - A total of 165 CoCs were assessed.



- One (1) non-compliance was identified. This relates to implementation of site erosion controls.
- Two (2) observations were identified. This includes implementation of Planning for Bush Fire Protection 2006 and shaping and stabilisation of the southern stockpile area.

The Auditor would like to thank the auditees for their organisation, cooperation and assistance during the Independent Audit.

1. INTRODUCTION

1.1 **Project overview**

The NSW Department of Education – School Infrastructure are responsible for delivering the Galungara Public School Development (the Project). The Project site is located on approximately 2 ha of land at Farmland Drive, Schofields, 35km north west of the Sydney Central Business District. The Project location is presented in Figure 1.



Figure 1: Project location (modified from Six Maps and Near Maps, 2022).

The Project involves construction of a new school to accommodate up to 1,000 primary students. The Project comprises:

- Stage 1a: Construction and operation of the core school facility, including library, hall, partial construction of COLAs and site landscaping, sports courts, and administration and staff facilities, and 19 home bases to cater for up to 600 students as set out in the Amended Staging Plan prepared by Richard Crookes Construction dated 12/10/20 and submitted with SSD- 9368-Mod-3.
- Stage 1b: Construction and operation of landscaped areas including the School Heart as set out in the Amended Staging Plan prepared by Richard Crookes Construction dated 12/10/20 submitted with SSD-9368-Mod-3.
- Stage 2: Construction and operation of the remaining 20 home bases and COLAs and final landscaping works and basketball/multiuse courts to increase the school capacity up to 1000 students as set out in the Amended Staging Plan prepared by Richard Crookes Construction dated 12/10/20 submitted with SSD-9368-Mod-3.

The Project was granted consent under Section 4.38 of the *Environmental Planning and Assessment Act 1979* on 21 May 2020, State Significant Development (SSD) 93678, subject to a



number of conditions. Subsequent to the Project consent the following modifications have been approved

- Alex Avenue Public School Modification 1 Staging. State Significant Development Modification Assessment (SSD-9368 MOD 1), October 2020. Approved 2 October 2020
- Alex Avenue Public School Modification 2 Design Amendments and Operational Readiness. State Significant Development Modification Assessment (SSD-9368 MOD 2), November 2020. Approved 2 December 2020
- Alex Avenue Public School Modification 3 Revised Staging. State Significant Development Modification Assessment (SSD-9368 MOD 3), December 2020. Approved 20 December 2020
- Alex Avenue Public School Modification 4 Easement, student capacity and landscaping (SSD-9368 MOD 4) is has been submitted to the Department of Planning and Environment (DPE) and has been exhibited. The response to submissions is currently being prepared.

Stage 1a and 1b of the school are now operational.

Stage 2 of the Project commenced construction on the 21 March 2022. This scope of this audit addresses Stage 2 of the Project.

TSA Management (TSA) has been appointed as the client representative on behalf of School Infrastructure NSW (SINSW). Richard Crookes Construction (RCC) is the principal contractor. The Principal Certifying Authority (PCA or the Certifier) is Group DLA.

Works undertaken since the commencement of operation of Stage 1 include:

- Notification to commence Stage 2 work was provided to DPE with construction commencing 21 March 2022
- Commencement of Stage 2 construction including site establishment, traffic management, installation of vehicle turntable to manage traffic movement and direction, commencement of the sports field ground remediation, earthworks and structural building work

1.2 Approval requirements

Conditions of Consent (CoC) C30 – C38 of Schedule 2 of SSD 9368 set out the requirements for undertaking Independent Audits. The CoCs give effect to the Department of Planning Industry and Environment (the Department) document entitled *Independent Audit Guideline Post Approval Requirements*, 2020 (IAPAR).

1.3 The audit team

In accordance with Schedule 2, CoC C38 and Section 3.1 of the IAPAR, Independent Auditors must be suitably qualified, experienced and independent of the Project, and appointed by the Planning Secretary.



The Audit Team comprises:

- Peter Hatton (Lead Auditor): Exemplar Global Certified Environmental Lead Auditor (Certificate No 206417).
- Derek Low (Reviewer), Exemplar Global Certified Lead Environmental Auditor (Certificate No 114283).

Approval of the Audit Team was provided by the Department on 1 June 2022. The letter of approval is presented in Appendix B.

1.4 The audit objectives

The objective of this Independent Audit is to satisfy SSD 9368 Schedule 2, CoC C33. It states:

Independent Audits of the development must be carried out in accordance with the Independent Audit Post Approval Requirements.

The audit frequency has been varied by SSD 9368 Schedule 2, CoC C31. It states:

Table 1 of the Independent Audit Post Approval Requirements is amended so that the frequency of audits required in the construction phase is:

(a) an initial construction Independent Audit must be undertaken within twelve weeks of the notified commencement date of construction under this development approval; and

(b) a subsequent Independent Audit of construction must be undertaken no later than six months from the date of the initial construction Independent Audit.

This Independent Audit was prepared in accordance with the IAPAR 2020 which reflects the requirements of CoC C31 and submitted to the Department and the Certifying Authority within twelve weeks of the date

This Independent Audit seeks to fulfill the requirements of CoC C31-34, verify compliance with the relevant CoCs and assess the effectiveness of environmental management on the Project.

1.5 Audit scope

This Independent Audit relates to the Project works from March 2022 to June 2022 (the audit period).

The scope of the Independent Audit, as per the 2020 revision of the IAPAR, comprises:

- "an assessment of compliance with:
 - all conditions of consent applicable to the phase of the development that is being audited
 - all post approval and compliance documents prepared to satisfy the conditions of consent, including an assessment of the implementation of Environmental Management Plans and Sub-plans; and



- all environmental licences and approvals applicable to the development excluding environment protection licences issued under the Protection of the Environment Operations Act 1997.
- a review of the environmental performance of the development, including but not necessarily limited to, an assessment of:
 - actual impacts compared to predicted impacts documented in the environmental impact assessment
 - the physical extent of the development in comparison with the approved boundary
 - incidents, non-compliances and complaints that occurred or were made during the audit period
 - the performance of the development having regard to agency policy and any particular environmental issues identified through consultation carried out when developing the scope of the audit; and
 - feedback received from the Department, and other agencies and stakeholders, including the community or Community Consultative Committee, on the environmental performance of the project during the audit period
- the status of implementation of previous Independent Audit findings, recommendations and actions (if any)
- a high-level assessment of whether Environmental Management Plans and Subplans are adequate; and
- any other matters considered relevant by the auditor or the Department, taking into account relevant regulatory requirements and legislation, knowledge of the development's past performance and comparison to industry best practices".

2. AUDIT METHODOLOGY

2.1 Audit process

The Independent Audit was conducted in a manner consistent with AS/NZS ISO 19011.2019 – Guidelines for Auditing Management Systems and the methodology set out in the Department's IAPAR. An overview of the audit activities, as specified in AS/NZS ISO 19011, is presented in Figure 2.

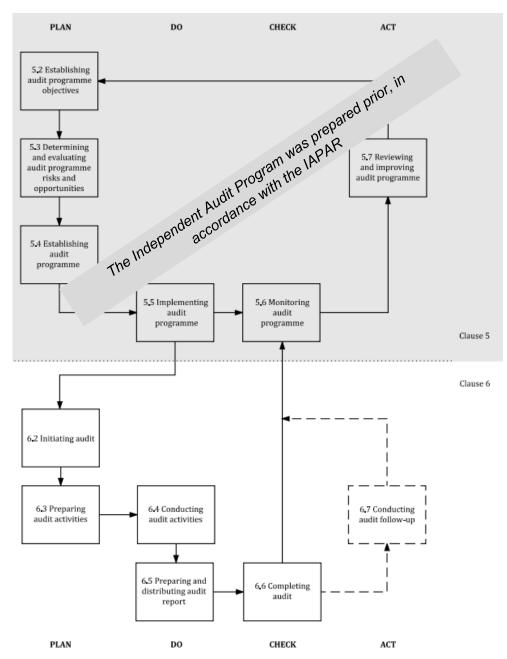


Figure 1 Audit activities overview (modified from AS/NZS ISO 19011). Subclause numbering refers to the relevant subclauses in the Standard.

2.2 Audit process detail

2.2.1 Audit initiation and scope development

Prior to the commencement of the audit the following tasks were completed:

- Establish initial contact with the auditee.
- Confirm the audit team.
- Confirm the audit purpose, scope and criteria.

On 2 June 2022 WolfPeak consulted with the Department to obtain their input into the scope of the Independent Audit and confirmation on whether other stakeholders should be consulted, as per Section 3.2 of the IAPAR. DPE did not provide a response indicating any areas of focus. The consultation records are presented in Appendix C.

2.2.2 Preparing audit activities

The Auditor performed a document review, prepared an audit plan, and prepared work documents (audit checklist) and distributed to the Project team in preparation for the Independent Audit.

The primary documents reviewed prior to the site visit are as follows:

- Environmental Impact Statement for Alex Avenue Public School, Urbis, February 2019 (the EIS)
- Response to Submissions Report Alex Avenue Public School_SSD_9368, Urbis, June 2019
- Consolidated Development Consent SSD 9368, 21 May 2020 (the Consent), including Modifications 1, 2 and 3.
- Alex Avenue Public School Modification 1 Staging. State Significant Development Modification Assessment (SSD-9368 MOD 1), October 2020
- Alex Avenue Public School Modification 2 Design Amendments and Operational Readiness. State Significant Development Modification Assessment (SSD-9368 MOD 2), November 2020
- Alex Avenue Public School Modification 3 Revised Staging. State Significant Development Modification Assessment (SSD-9368 MOD 3), December 2020
- Galungara Public School Stage 2 SSD 9368 Construction Environmental Management Plan, Richard Crookes Constructions, Rev 2, 11 March 2022 (CEMP)
- Community Communication Strategy Stage 2 Galungara Public School, March 2022 (CCS)
- Construction Traffic Management Plan, *Job Site 28 Farmland Drive, Schofields, 2762, V2.2 Jim's Traffic Control, 11/03/2022 (CTMP)*
- Construction Noise and Vibration Management Plan Galungara Public School, Rev B. JHA Services, 11 March 2022 (CNVMP)

The audit checklist was reviewed and prepared comprising all conditions from Schedule 2 of SSD 9368.

2.2.3 Site personnel involvement

The site inspection took place on 2 June 2022, with an interview session held on 14 June 2022.

2.2.4 Meetings

Opening and closing meetings were held with the Auditors and Project personnel.

During the opening meeting the objectives and scope of the Independent Audit, the resources required and methodology to be applied were discussed. At the closing meeting, preliminary audit findings were presented, preliminary recommendations (as appropriate) were made, and any post-audit actions were confirmed.

2.2.5 Interviews

The Auditor conducted interviews remotely with key personnel during and following the site inspection. During the inspection key sites were inspected with personnel involved in on-site Project delivery, including those with responsibility for environmental management, to assist with verifying the compliance status of the development. All other communication was conducted remotely, which included detailed request for information and auditee responses to the request.

2.2.6 Site inspection

A site inspection was conducted on 2 June 2022. The on-site audit activities included an inspection of the entire site and work activities. Photos are presented in Appendix D.

2.2.7 Document review

The Independent Audit included investigation and review of Project files, records and documentation that acts as evidence of compliance (or otherwise) with a compliance requirement. The documents sighted are included within Appendix A.

2.2.8 Generating audit findings

Independent Audit findings were based on verifiable evidence. The evidence included:

- Relevant records, documents and reports
- Interviews of relevant site personnel
- Photographs
- Figures and plans; and
- Site inspections of relevant locations, activities and processes.

2.2.9 Compliance evaluation

The Auditor determined the compliance status of each compliance requirement in the Audit Table (Appendix 1), using the descriptors from Table 2 of the IAPAR, being:

Table 2: Compliance status descriptors

Status	Description
Compliant	The Auditor has collected sufficient verifiable evidence to demonstrate that all elements of the requirement have been complied with within the scope of the audit.
Non-compliant	The Auditor has determined that one or more specific elements of the conditions or requirements have not been complied with within the scope of the audit.
Not Triggered	A requirement has an activation or timing trigger that has not been met at the time when the audit is undertaken, therefore an assessment of compliance is not relevant.

Observations and notes may also be made to provide context, identify opportunities for improvement or highlight positive initiatives.

2.2.10 Evaluation of post approval documentation

The Auditor assessed whether post approval documents:

- have been developed in accordance with the CoCs and all other environmental licences and approvals applicable to the Project (if any) and their content is adequate.
- have been implemented in accordance with the CoCs and all other environmental licences and approvals applicable to the Project (if any).

The adequacy of post approval documents was determined on the basis of whether:

there are any non-compliances resulting from the implementation of the document; or



• whether there are any opportunities for improvement.

2.2.11 Completing the audit

The Independent Audit Report was distributed to the proponent to check factual matters and for input into actions in response to findings (where relevant). The Auditor retained the right to make findings or recommendations based on the facts presented.

3. AUDIT FINDINGS

3.1 Approvals and documents audited and evidence sighted

The documents audited comprised all the conditions from Schedule 2 of SSD 9368 applicable to the works being undertaken, and selected mitigation measures and commitments from the following plans that relate to compliance:

- CEMP
- CTPMSP
- CSWMSP
- CNVMSP and
- CWMSP

The evidence sighted against each requirement is detailed within Appendix A.

3.2 Non-compliances, Observations and Actions

This Section presents the non-compliances and observations from the Independent Audit. Actions in response to each of the findings are also presented. Detailed findings against each requirement are presented in Appendix A.

- As this is the first Independent Audit for Stage 2 work there are no open findings and recommendations from the previous Audits
- With respect to the finding from this first Independent Audit of Stage 2:
 - A total of 165 CoCs were assessed.
 - One (1) non-compliance was identified. This relates to implementation of site erosion controls.
 - Two (2) observations were identified. This includes implementation of Planning for Bush Fire Protection 2006 and shaping and stabilisation of the southern stockpile area.

3.3 Adequacy of Environmental Management Plans, sub-plans and post approval documents

The adequacy of post approval documents must be determined on the basis of whether:

- There are any non-compliances resulting from the implementation of the document; and
- Whether there are any opportunities for improvement.

A review was conducted of the:

- CEMP
- CTPMSP
- CNVMSP
- CWMSP; and
- CSWMSP.

The documents are considered to be generally adequate for the works being undertaken.

3.4 Summary of notices from agencies

The Auditor is not aware of any notices served on the Project by agencies.

3.5 Other matters considered relevant by the Auditor or DPE

Other than the findings identified (in Section 3.2 above) there were no other matters considered relevant by the Auditor in relation to the audit. No issues were raised by the Department during the consultation in preparation for this Independent Audit outside the scope of the IAPAR.

It is noted however that WolfPeak requested an extension to the audit submission date from the Department on 20 July 2022. On 26 July 2022 the Department granted an extension to 16 August 2022. This approval is included within the consultation records in Appendix C.

3.6 **Complaints**

A complaints register is being maintained by the Project. The register is published monthly on the Project website.

No complaints were recorded during the audit period.

3.7 Incidents

The Project has not identified any notifiable incidents as defined by the Consent.

3.8 Actual versus predicted impacts and environmental performance

The audit considered the actual impacts arising from the carrying out of the Project and whether they are consistent with the relevant impacts predicted in the EIS. A summary of the assessment is presented in Table 4.

The Auditor is of the view that the auditees environmental performance is sound. Whilst some improvement opportunities were identified around erosion and sediment control, the impacts are not considered material and would be consistent with that predicted in the EIS.

4. CONCLUSIONS

This Audit Report presents the findings from the first Independent Audit for the Stage 2 construction period, covering the period of March 2022 to June 2022 (the audit period).

The overall outcome of the Independent Audit indicated that compliance is being proactively tracked by RCC and TSA. Compliance records were well organised and available at the time of the site inspection and interview with RCC and TSA personnel following the site visit. Relevant environmental and compliance monitoring records are being collected and reported as required to provide verification of compliance to statutory requirements and the broader Project environmental requirements.

Detailed findings are presented in Section 3, along with actions to address each of the findings. The findings are summarised as follows:

- As this is the first Independent Audit for Stage 2 work there are no open findings and recommendations from the previous Audits
- With respect to the finding from this first Independent Audit of Stage 2:
 - A total of 165 CoCs were assessed.
 - One (1) non-compliance was identified. This relates to implementation of site erosion controls.
 - Two (2) observations were identified. This includes implementation of Planning for Bush Fire Protection 2006 and shaping and stabilisation of the southern stockpile area.

The Auditor would like to thank the auditees for their high level of organisation, cooperation and assistance during the Independent Audit.


