## Lane Cove Public School

### Project update

February 2022

Construction continues at Lane Cove Public School to replace the school hall and canteen facilities that were destroyed in a fire in 2020.

The project will deliver:

- a new school canteen with restoration works to the adjacent playground area
- a new school hall and attached covered outdoor learning area (COLA).

The new canteen facilities are located on the site of the previous school hall. The new school hall will be built on the site known as 'The Bullring'.

### Progress update

The construction program for the new hall has been developed and construction activities have started. This includes:

- removal of the temporary canteen and installation of a booster pump from Longueville Road
- installation of perimeter fencing to restrict access to the construction site
- installation of safety crossing gates across the vehicle access point
- installation of work sheds, meeting room and amenities within the construction site
- start of demolition works.

### Next steps

- finish demolition works
- start excavation and groundworks to prepare for the new hall, weather dependant
- bricks from 'The Bullring' will be removed and shared with the school as requested.

We will continue to share project updates and notifications as construction progresses.

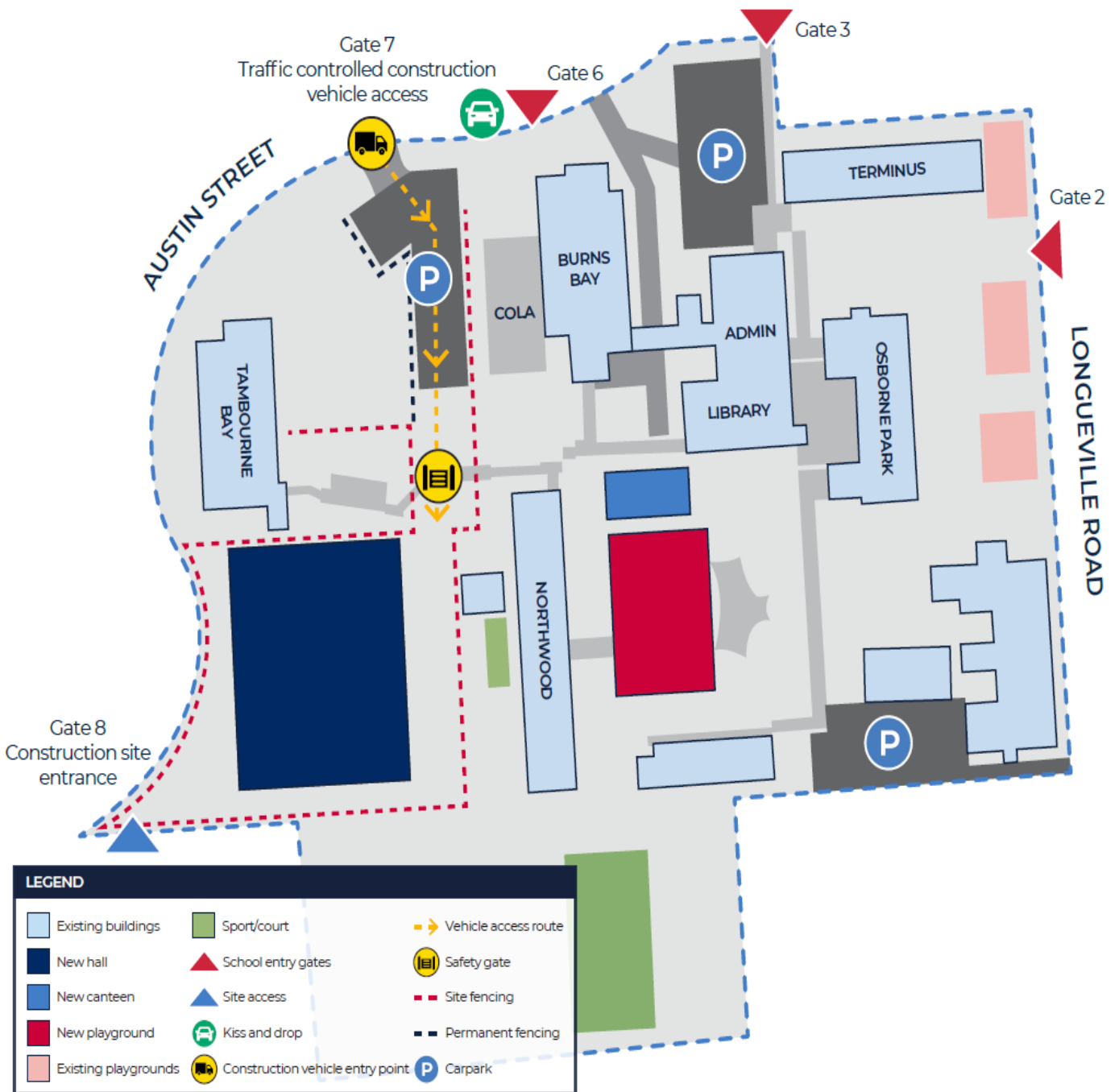

## Frequently asked questions

### When will construction be finished?

The project is expected to be finished in late 2022, dependent on site and weather conditions.

### What will the construction hours be?

Construction hours will be between 7 am to 5 pm Monday to Friday, and on Saturdays from 8 am and 4 pm. There will be no construction on Sundays or Public Holidays, unless otherwise notified.

### Will there be any changes to the kiss and drop zone?

The kiss and drop zone has returned to its previous location on Austin Street at the front of the school.

### What entrances will students use?

Students will be able to enter the school grounds via Gates 2, 3 and 6. During construction Gate 8 will only be accessible for personnel working at the construction site.

### Is the school car park operational?

The school car park accessed via Gate 7 will not be operational during construction. It will be used for vehicle access to the construction site and therefore no cars will be able to park in the allocated parking spaces.

### Where will staff parking facilities be located?

We have secured usage of 17 car spaces at the Lane Cove Council car park across the road from Lane Cove Public School. School staff will be able to use these spaces for the duration of construction period at no cost to the individual. No other car parks within the school will be impacted during construction and will continue to be used by staff.

### How will vehicles access the construction site?

Vehicles will enter the construction site via Gate 7 located on Austin Street and use the existing internal road of the school car park. Safety gates have been installed at the walkway that connects the Tambourine Bay building to the main school. Traffic control personnel will be present when required to safely direct pedestrians and vehicles to and from the construction site including opening and closing of safety gates.

Truck movements will be scheduled to outside school drop-off and pick-up times, where possible, to minimise disruption to students and staff.

### Will traffic management be in place?

Traffic management will be in place where required for the safety of students, staff, the local community and workers. Vehicles will give way to pedestrians at all times.

### How will noise and dust be managed?

Noise and dust control measures will be implemented in accordance with planning approval requirements. Secure fencing and shade cloth will be installed to reduce noise and dust impacts on the school and local residents. Dust from construction works will be hosed down as required.
