The New South Wales Rural Fire Service (NSW RFS) has reviewed the Landscape Management Plan prepared by Designinc Pty Ltd dated 24 August 2018. No concerns are raised in relation to the works proposed for the five management zones. The annual monitoring to ensure ongoing fuel management within the subject site is supported.

Clarification is required on the following:

- Existing approved asset protection zones (APZs) are shown on Figure 5 in the report. It is unclear if this area is covered under this Landscape Management Plan and meets the requirements of section 4.1.3 and Appendix 5 of *Planning for Bush Fire Protection 2006* and the NSW Rural Fire Service's document *Standards for asset protection zones.*
- Monitoring of the Landscape/Vegetation Management Plan will be conducted under the provisions of Alphitonia VMP (2016) as per the report. This plan has not been provided for review.
