Investing in our schools

The NSW Government is investing \$7 billion over the next four years, continuing its program to deliver more than 200 new and upgraded schools to support communities across NSW. This is the largest investment in public education infrastructure in the history of NSW.

The NSW Department of Education is committed to delivering new and upgraded schools for communities across NSW. The delivery of these important projects is essential to the future learning needs of our students and supports growth in the local economy.

Project overview

School Infrastructure NSW (SINSW) is planning to upgrade the facilities at Liverpool West Public School. Current scope includes:

- 8 new classrooms and associated administration, canteen and OSHC facilities.
- Refurbishment to two existing classrooms.
- Expanded school hall and covered outdoor learning area (COLA).
- Refurbishment within the pre-school buildings.
- Car park extension.

This project is being carried out under the following planning legislation, *State Environmental Planning*

Policy (Educational Establishments and Child Care Facilities) 2017 (Education SEPP) and State Environmental Planning Policy (Infrastructure) 2007 (Infrastructure SEPP).

The scope of works is classified as Development Permitted without Consent and accordingly a Review of Environmental Factors (REF) report is now being prepared.

The early works package, planned for later this year, includes:

- Demolition of existing canteen.
- Infrastructure upgrades and service connections (electrical, water, sewer).
- Refurbishment of existing classrooms.
- Associated Landscape works.

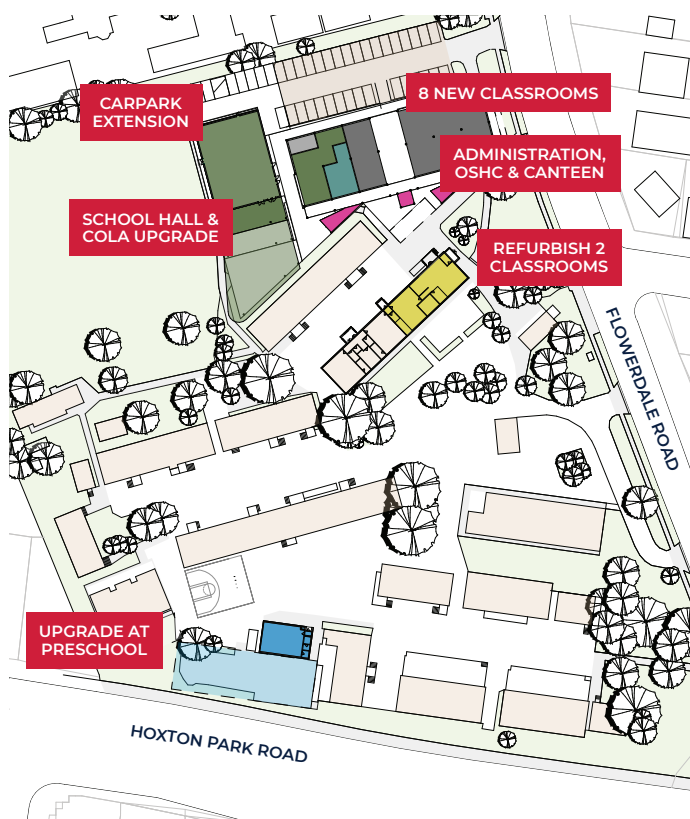

Frequently asked questions

When will the work take place?

Early work is expected to start Term 4 this year, with the main works occurring across 2022. The upgrade is expected to be ready for Term 1, 2023.

Will there be a Development Application (DA) for this project?

The infrastructure upgrade works include electricity transmission, flood mitigation works, gas supply, sewerage, stormwater, telecommunications and water supply (which are able to be undertaken under clauses of the Infrastructure SEPP). All other works, including demolition, refurbishment and landscaping works can be undertaken under Clause 36 of the Education SEPP.

These clauses enable this development to be carried out without consent, so no DA is required. However, a Complying Development Certificate (CDC) will be submitted for all remaining works that form part of the larger project.
