- 1. This Crown Certificate does not certify compliance with the conditions of Development Consent. The building works should not commence until the Crown is satisfied that the conditions of development consent that are a pre-requisite to commencement have been appropriately addressed where relevant.
- 2. All building works associated with the subject development are to be carried out in accordance with the requirements of the Blackett Maguire + Goldsmith BCA Assessment Report Revision 2 dated 03.12.2019
- 3. All building works associated with the subject development are to be carried out in accordance with the approved documentation listed above in Schedule 1.
