

CONDITIONS OF BCA CROWN CERTIFICATE

This Crown Certificate has been issued subject to the following conditions:

- 1. This Crown Certificate does not certify compliance with the conditions of Development Consent. The building works should not commence until the Crown is satisfied that the conditions of development consent that are a pre-requisite to commencement have been appropriately addressed where relevant.
- 2. All building works associated with the subject development are to be carried out in accordance with the approved documentation listed above in Schedule 1.
- 3. All works associated with the MGAC Accessibility report dated 26 October 2021 are to be undertaken and implemented.
- 4. To address the requirements of Condition B5 the Section 73 compliance certificate prepared by Sydney water is to be obtained.
- 5. The statement prepared by PWNA dated 28 October is to be supplemented by a set of drawings which clearly show the noise mitigation measures identified in the SSD Application Acoustic Assessment dated 30 April 2021 and prepared by Aurecon prior to works associated with the installation of mechanical plant commencing.
- Prior to the commencement of construction of operational parking and access facilities, evidence of compliance of the design of operational parking and access arrangements as described in DA condition B22 must be submitted to the satisfaction of BM+G.
- 7. Prior to the commencement of any footpath or public domain works evidence of consultation with Council is to be provided which demonstrates that the streetscape design and treatment meets the requirements of Council.
- 8. The comments and recommendations made in the BCA report prepared by BM+G are to be addressed.
