# New public preschool at Bowraville Central School

Planning update | May 2024

The NSW Government's 2023-24 Budget is delivering a record \$8.8 billion for new and upgraded schools. This targeted investment in growing communities will ensure working families get access to a world class public education.

### 100 new public preschools

As part of the plan to rebuild essential services, the NSW Government is investing \$769 million to deliver 100 new public preschools, including building new public preschools at new government primary schools in NSW, to boost access to public preschool across the state.

#### New public preschool at Bowraville Central School

The new public preschool at Bowraville Central School will be among the <u>100 public preschools</u> to be built across NSW by 2027, pending building and regulatory approvals.

More details about the opening timeframes, size and operation of the public preschool at Bowraville Central School, including how to enrol, will be shared as they become available.
