

Cringila Public School

Works notification | April 2025

Dear staff and neighbours,

As part of Cringila Public School remediation project, we will begin working in an area that shares a boundary with Lackawanna Street properties from Monday May 5 2025.

Please remove any saplings, vegetable gardens or personal effects before work starts.

Neighbouring properties will no longer have access to departmental land from this date, per the *Inclosed Lands Protection Act 1901*.

What to expect

- tree removal, mowing grass and slashing weeds
- excavation of top soil and removal of large rocks
- installing a 1.8 metre Colorbond fence on school land
- constructing new gabion retaining walls and a swale drain.

This area is known to contain bonded asbestos and is listed in the school's asbestos register.

NSW Health explains living, working or being around asbestos is a low risk to your health if the asbestos is in good condition and not damaged.

Safety measures, including air monitoring will be in place while work is being done.

Work will be monitored by independent hygienists, in accordance with work health and safety laws and the NSW Department of Education's Asbestos Management Plan.

The remediation project is expected to be completed during Term 3 2025.

Managing construction impacts

Contractors, deliveries and machinery will access the site via the school grounds and double gates which will be installed in the Cringila Hills Mountain Bike Park boundary fence line.

Work hours are between 7 am and 6 pm Monday to Friday, and 8 am and 1 pm on Saturday, in line with NSW Environment Protection Authority guidelines.

Residents are advised to expect noisy works when an excavator is in use.
